NOW THERFORE, the County Assembly urges the Department of Health in collaboration with the Ministry of Health at the National Level to;

- i. Establish programs to sensitize people on the management of snake bites
- ii. Consider budgetary allocation in the subsequent financial years to ensure timely supply and free administration of the anti-venom in public health facilities, concentrating on sub county health facilities in the County, and further ensure that these facilities are equipped with the necessary infrastructure for the storage of the anti-venom.
