9. MOTION-ESTABLISHMENT OF REHABILITATION CENTERS OF RECOVERING DRUG ADDICTS

AWARE THAT; Article 43 of the Constitution of Kenya 2010 under Economic and Social rights every person has the right to attainable standard of health, which include the right to health care services.

FURTHER AWARE; that, Article 53 of the Kenya Constitution of Kenya 2010 gives every child the right to be protected from abuse, neglect and harmful cultural practices.

CONCERNED THAT; despite the existence of an extensive legal framework, many of the victims of drug abuse who are willing to reform are not able to access affordable rehabilitative services.

DEEPLY CONCERNED THAT; there are no designated rehabilitation centers in the County to provide the much needed services of rehabilitating the drug addicts. **NOTING THAT**, the County should provide and take measures including affirmative action program to ensure that the youth have opportunities to participate in political, social, economic and other spheres of life since most of the young people in the county engage in drug abuse due to idleness, lack of adequate information of the dangers of abusing drugs and peer pressure;

NOW THEREFORE the County Assembly calls upon the County department of Health to take measures to:

- 1. Establish and adequately equip rehabilitation centers for recovering drug addicts in Tharaka Nithi County;
- 2. Provide treatment and counseling services to victims of drug abuse.

NOW THEREFORE, the County Assembly urges the Department of Roads, Infrastructure, Housing, Public Works, ICT & Energy to;

- 1. Established and clearly mark designated parking spaces for people living with disability in bus parks and Government buildings' parking.
- 2. Ensure that all the commercial buildings in the County have designated parking spaces for people living with disability.
