- 1. The House (County Assembly) assembled at thirty minutes past nine O'clock.
- **2.** The proceedings were opened with prayer said by the Hon. Speaker.
- 3. Communication from the Chair;

The Speaker conveyed the following Communication from the Chair:

## "Honorable Members,

As you are aware, pursuant to the House Resolution of 27<sup>th</sup> June, 2023 the House adjourned to reconvene on notice by the Honorable Speaker. On 12<sup>th</sup> October vide the letter **Ref TN/CA/ADM/3/VOL.II/500** I gave notice of today's sitting.

## Honorable Members,

I wish to recognize the Presence of pupils from Consolata Primary and Junior Secondary School who are seated in the gallery. The pupils are accompanied by teacher Purity, teacher Pamela and teacher Anthony.

On behalf of the County Assembly of Tharaka Nithi I wish to welcome the pupils to the County Assembly and wish them a delightful stay as they get to learn on the conduct of business in the County Assembly.

## Honorable Members,

The Speaker's Rules are made pursuant to powers conferred by Section 38 of the County Assemblies Powers and Privileges Act 2017. Members are strongly advised to be fully conversant with the provisions of the said Act –which among other things defines certain powers, privileges and immunities of the Assembly, Committees and the Members of the County Assembly.

Standing Order 207 provides that the procedure in a committee shall be as nearly as possible the same as that in the Assembly.

Section 38 of the County Assemblies Powers and Privileges Act 2017 provides for the Speaker's orders. It provides that:

- (1) The Speaker may, from time to time, issue such orders as may be necessary or expedient for the better carrying out of the purposes of this Act.
- (2) Without prejudice to the generality of the foregoing, the orders may provide for—
  - (a) the admittance of members of the public to the precincts of a county assembly;
  - (b) the deduction of any monies due to a member in respect of refreshments or other facilities made available to members within the precincts of a county assembly;
  - (c) the appropriate dress code for members.
- (3) The Speaker may, from time to time as may be expedient, issue a Code of Conduct regulating the conduct of members of the county assembly whilst within the precincts of the county assembly other than the chamber.

Further, Section 5(c) provides that:

For the purposes of Article 94(6) of the Constitution the principles and standards applicable to the order and Code of Conduct made under this section are the usages, forms, precedence, customs, procedures and traditions of the Parliament of Kenya and other jurisdictions to the extent that these are applicable to Kenya.

In light of the above and as per the County Assembly speaker's rules, Members of the County Assembly are expected to attend sittings of a County Assembly dressed respectably. In Parliamentary culture, men dress in full suit or broken suits with a tie while ladies put on decent official dress or suit.

Members of the County Assembly, members of the press and guests should not enter the Chamber, or Committee Rooms without being properly dressed. The Honorable Members of the County Assembly are expected to dress in a dignified manner that preserves the standards and ensure decency within the precincts of the County Assembly and in a manner that demonstrates the respect of the Assembly and its eminence in the society.

I therefore direct that whenever the Members of the County Assembly appear in the County Assembly or its Committees to transact business, they should do so in a decorous attire befitting their stature as Members of the County Assembly and in keeping up with the dignity of the Assembly.

## Honorable Members,

In addition to the Speaker's Rules, Members are advised to be fully conversant with all other laws which define the powers, privileges and immunities of the Members. Breach of the Speaker's Rules will usually result in the matter being referred to the Committee on powers and Privileges for consideration and action. The Members who continually dress improperly will be deemed to be disorderly and may be subject to applicable sanctions.

Honorable members I wish you all the best as you continue to fulfill your constitutional mandate.

- ii. That clause 1 be amended by deleting the word 'Itugururu' and replacingit therefor with 'Tharaka Nithi County'
- iii. **That Clause 10** sub-clause (2) be amended by deleting '3 (three) years' and replacing it therefor with '5 (five) years'
- iv. **That Clause 10** sub-clause (4)(h) be amended by inserting the word 'other' between the words 'any' and 'function', deleting the word 'signed' appearing between the words 'be' and 'by' and replacing it therefor with the words 'assigned' and insert the word 'board' between the words 'the' and 'from'.
- v. **That Clause 11** sub-clause (1)(f) is amended by deleting the words 'physical or' and 'and' where they appear.
- vi. That Clause 15 (1) be amended by inserting the words 'there is established a fund to be known as the Tharaka Nithi County Agricultural Training Center Fund' before the words 'the Funds of the Centre'.
