**1.** The House (County Assembly) assembled at thirty minutes past two o'clock.

## 2. ARRIVAL OF HIS EXCELLENCY THE GOVERNOR

The Governor of the Tharaka Nithi, His Excellency Hon. Muthomi Njuki, escorted by the Speaker of the County Assembly and accompanied by Mace of the House, entered the Chamber at forty minutes past Two O'clock.

**3.** The Proceedings were opened with Prayer said by the Hon. Speaker.

## 4. CONVOCATION BY THE SPEAKER

The Hon. Speaker conveyed the following:

"Our Excellency Honorable Muthomi Njuki the Governor Tharaka Nithi County, Honorable Members, all invited guests, ladies and gentlemen it gives me great pleasure this morning to welcome you to this historical moment and a very uniquely placed sitting in the history of Parliament, and most importantly the County Assembly of Tharaka Nithi.

Honorable Members, as you are aware Section 30(2)(k) of the County Government Act 2012 provides that the County Governor shall among others deliver annual state of the County address containing such matters as may be specified in County Legislation. Further, the Tharaka Nithi County Assembly Standing Order 31(1) provides that the Governor shall address a special sitting of the Assembly once every year and may address the Assembly at any other time.

Your Excellency and all our invited Guests "History is written by those who dare to take the Journey" indeed today as we take this Journey of re-writing the history of Parliaments in the world. You and I are a witness that the 2nd Assembly of the County of Tharaka Nithi shall be addressed, in a special moment, by His Excellency the Governor, on a state of the County address pursuant to Standing Order 31, and by an invited dignitary distinguished Hon. Kareke Mbiuki, MP, CBS a leader and an icon for not just the great people of Maara but also the Republic of Kenya. The visiting dignitary will address the House pursuant to the County Assembly of Tharaka Nithi Standing Order 34.

Following the receipt of the message from His Excellency regarding the address of this House in line with Standing Order 31 and the County Government Act, 2012 Section 30(2)(k), the House in its Wednesday 15th December, 2021 Morning sitting accordingly resolved that this sitting be held here at the Kathwana Municipality pavilion. I therefore wish to confirm that this sitting is properly constituted in accordance with the Standing Orders and declare this dome a County Assembly Chamber until such a time that the House is adjourned upon the address by His Excellency the Governor.

Your Excellency the Governor, honorable Members, it is the custom of the Assembly to recognize invited guests seated at the Speaker's gallery. I therefore wish to accord special recognition to the distinguished guests seated at the Speakers gallery in this order (when I call your name kindly stand and wave):

Your Excellency, Honorable Members, our distinguished guests and the people of Tharaka Nithi, I wish to note that Parliaments and indeed the County Assembly of Tharaka Nithi, are guided by the Standing Orders and parliamentary practices which over time have developed to ensure

order and rules of engagements. I therefore wish to spell out the following rules of procedures during this historical sitting of the House:

i. Pursuant to the provisions of Standing Order 125 Except when passing to and from his or her seat, every Member when in the Chamber shall be seated, and shall not at any time stand in any of the passages and gangways.

ii. I wish to direct that there shall be no unnecessary movement in and out of the chamber especially when His Excellency the Governor, our visiting dignitary and the Speaker shall rise to address the House.

iii. Only Uniformed officers of the House shall be allowed in the chamber for purposes of carrying out parliamentary duties Including and enforcing order and the directives of the Speaker.

iv. All our Parliamentary Broadcasting rules shall apply.

v. That where our distinguished guests are seated shall be the Speakers row and gallery, while where the members of the public are seated shall be in the intervening period be the public gallery, and like I had earlier directed both galleries shall be part of the House and all the rules shall apply.
