3. STATEMENT ON WATER CONSERVATION IN THE COUNTY.

(Hon. Justin Kithinji, MCA)

Mr. Speaker Sir, I rise pursuant to the provisions of Standing Order No.55 (1) (a) to seek a statement from the Chairperson committee on Water Environment and Natural Resources on water conservation in the County.

Despite the numerous allocations and purchase of water drilling equipment there has been persistent water shortage for both domestic and agricultural use in various parts of the County that need to be addressed urgently.

In the Tharaka Nithi County Government Budget Estimates for the financial year 2018/2019 the County Government allocated funds towards water harvesting in schools and construction of water pans in various wards across the County.

In the statement, the chairperson should respond to the following:

- i. How many water pans have been drilled since inception of the program?
- ii. How many of those water pans are functional and their locations?
- iii. Did the department sensitize the residents in those areas on how to harvest and store the water in the water pans?
- iv. Which schools benefited from the allocation on water harvesting tanks?
- v. What is the County Government doing to ensure that they harvest and store adequate water reserves during the rainy season for use during the dry seasons?
