AWARE THAT; Section 50(1) of the County Government Act, No. 17 of 2012 provides that there shall be established at the level of each sub-county the office of the Sub-County Administrator.

FURTHER AWARE THAT; Section 50(3) of the County Government Act, No. 17 of 2012 makes provision for the responsibilities of the sub-county administrator as coordination, management and supervision of the general administrative functions in the sub- county unit.

COGNIZANT THAT; through Gazette Notice No. 1236 and 1237 of February 2022 there was established Chiakariga, Muthambi and Maara Sub-Counties respectively.

NOW THEREFORE; The County Assembly of Tharaka Nithi urges the County Executive through the County Public Service Board to fast-track the process of recruiting the Sub- County Administrators for the newly

established sub-County units and operationalize the Sub-County offices within sixty days for ease of service delivery and co-ordination of County Government functions.
