- iv. That Clause 7 Subclause 4(g) be amended by inserting the words 'in consultation with the liquor dealers association' at the end of the subclause;
- v. That Clause 7 subclause 4(h) be amended by deleting the words 'one of whom shall be a' appearing after the word 'Member' and before the word 'youth' and substitute therefor with the words 'taking into account the';
- vi. That Clause 11 Sub Clause 3 be amended by deleting the words 'and the time, date and place of the meeting' appearing after the words 'applied for' and before the words 'and shall forthwith';
- vii. That Clause 11 Sub-clause 3(a) be amended by deleting the words 'for a period not less than 21 consecutive days' appearing at the end of the subclause;
- viii. That Clause 11 be amended by deleting the entire sub clause 3(c), subclause 3(d) and subclause (4);
