**NOTICE** is hereby given that the Chairperson- Committee on Transport, Public Works and Infrastructure intends to move the following amendments **to the** 

### Tharaka Nithi County Road Asset Management Bill, 2021:

- 1. Amend Clause 5(e) by inserting the word 'three' immediately after the words 'any other'.
- 2. Amend Clause 8(1) and 8(3 by deleting the word 'Location' and substituting therefor with the word 'Sub-Location'.
- 3. Amend Clause 12(1) by deleting the sub-clause 'Any person who without authority or the consent of the Directorate erects, places or retains a temporary structure on any type of the road shall be guilty of an offence' and substituting therefor with sub-clause 'If a person without authority or the consent of the Directorate erects, places or retains a temporary structure on any type of the road, such a structure shall be deemed as an illegal structure'.
- 4. New Clause

Amend the Bill by inserting the following new clause immediately after Clause 19.

20. Building Lines

'Any person constructing a permanent structure in plots or land abutting a classified or unclassified road shall observe a setback distance of -

(a) between 3m and 6m road with the building line shall not be less than 3m;

(b) between 6m and 18m road width the building line shall be not less than 6m; and

(c) Any road greater than 18m in width, the building line shall be not less than 9m.

5. New Clause

Amend the Bill by inserting the following new clause immediately after Clause 20.

21. Road Reserve Width
