- 1. Amend brim code 103(d) of the bill by Deleting the word 'etc.' appearing after 'probox' and replacing it therefor with the word 'tricycle'.
- 2. Amend Brim code 103(e) of the Bill by:
 - a. Inserting the words 'where applicable' after the words 'per instance'
 - b. Delete the figure '10,000' and replace it therefor with the figure '5,000'

 - a. Delete '7000' as appearing under R-25(a) of the Slaughterhouse license and replace it therefor with '3000'
