STATEMENT ON INCONSISTENT WEATHER PATTERNS IN THARAKA NITHI COUNTY;

(Hon. Njagi Mucee John, MCA)

Mr. Speaker Sir, I arise pursuant to provision of Standing Order No 55 (1) to seek a statement from the Chairperson Committee on Water, Environment and Natural Resources.

Historically Embu, Tharaka Nithi and Meru Counties experienced continuous rainfall from October-May in one season and some showers in July to early August every year until in the mid-80s when the new trends of two seasons between October- December and March- May, long and short rains respectively started.

Consequently, the Counties have been experiencing trends of decreased rainfall in the two seasons and rising temperatures especially in January, February and March. The rainfall is usually unreliable and poorly distributed making agricultural activities within the Counties untenable. This phenomenon has led to low crop yields resulting to food insecurity and sometimes droughts.
