4. STATEMENT ON DUES OWED TO NATWANA THARAKA MULTIPURPOSE COOPERATIVE SOCIETY

(Hon. Gitonga Leonard, MCA)

Mr. Speaker Sir, I rise pursuant to the provisions of Standing Order No.55 (1) (a) to seek a statement from the Chairperson committee on Trade, Tourism and Cooperatives.

The Tharaka Nithi Cereals Marketing Cooperative Union limited signed memoranda of understanding with various stockists / cooperatives among them NATWANA THARAKA MULTIPURPOSE COOPERATIVE SOCIETY to purchase and store the (ndengu) bought from farmers on its behalf and use the Cooperatives to channel payments.

Two years down the line, the above farmers among others that supplied the Union with (ndengu) are yet to receive their dues.

In the statement, the Chairperson should respond to the following:

- 1. When will the farmers of Natwana Tharaka Multipurpose Cooperative Society be paid their dues?
- 2. How many other farmers and their details supplied the stockist with their products and are not yet paid?
- 3. What are the total outstanding balances owed to the concerned farmers?
- 4. What is the department doing to ensure that those farmers are paid and compensated for the losses suffered?

4. STATEMENT ON BANK GUARANTEE FOR CEREALS MARKETING COOPERATIVE UNION

Mr. Speaker, Sir. I rise pursuant to the provisions of Standing Order No.55 (1) (a) to seek a Statement from the Chairperson Assembly committee on Trade Tourism Cooperatives on the Bank Guarantee for Cereals Marketing Cooperative Union.

On 5th June 2018 this Honorable House approved a bank guarantee of Kshs. 15 million for the Cereals Marketing Cooperative Union Limited to procure green grams and other cereals in Tharaka Nithi County.

The amount was meant to enhance the County's cereal supply chain by offering good prices to farmers and stabilizing the prices during harvest time.

I hereby seek the information from the Chairperson Assembly Committee on Trade, Tourism and Cooperatives on:

- i. How the Kshs. 15million was used and the number of beneficiaries?
- ii. Did the loan benefit the intended farmers?
- iii. Which region benefited from the loan?
- iv. Was the loan repaid and at what interest?
- v. What is the department doing to ensure farmers enjoy benefits of standardized prices?
