# PROCEDURAL MOTION

HANDLING OF MESSAGES, REPORTS AND CRITICAL BUSINESS
WHEN THE ASSEMBLY IS NOT IN SESSION

**Hon. Deputy Speaker:** Yes, the mover.

**Hon. Karangi:** Mr. Speaker I rise to move a procedural Motion on the handling of messages and critical business while the Assembly is not in session.

Aware that; the Assembly Standing Order 53 (2) provides that if a message is received from the Governor or the Senator of the County, at a time when the Assembly is not in session, the Speaker shall forthwith cause the message to be transmitted to every Member and shall report the message to the Assembly on the day the Assembly next sits;

Cognizant that; the Assembly is set to proceed for recess as per the approved Tharaka Nithi County Assembly Calendar;

Recognizing that; we as an assembly need to device ways on how the effects of the pandemic do not affect our service delivery as provided for under Article 185 of the constitution of Kenya and section 8 of the County Government Act 2012;

Now therefore; for uninterrupted flow of County business during and at any time when the Assembly is not sitting either during recess or otherwise and not notwithstanding the provisions of Standing Order 81 (1), this Assembly resolves that the Speaker do refer any report received in accordance with Article 183 (3) of the Constitution of Kenya, 2010 to the relevant County Assembly Committee.

Mr. Speaker as I move this Motion I want to update the members that yesterday we had a virtual meeting as ABC, we did not do it physically, and we agreed because of the Pandemic that is affecting the world and that the business of the assembly has to be transacted every business for this Assembly will be presented to the committees for the committees to handle it. We said if possible the committee meetings will be virtual as you communicated earlier Mr. Speaker to avoid interruptions.

I beg the members to support this Motion so that as we proceed to our short recess which is around 14 days we be aware that we have a serious pandemic with us and it is affecting everyone each and every day. The members should support this Motion because we are dealing with unprecedented challenges and we have to work for the people of Tharaka Nithi under whatever circumstances that we are in.

With that I ask honourable Wilson Derebia, the member for Muthambi to second.

Hon. Deputy Speaker: Thank you honourable Muthini Karangi and honourable Wilson Derebia. I now propose the question that for uninterrupted flow of County business during and at any time when the Assembly is not sitting either during recess or otherwise and not notwithstanding the provisions of Standing Order 81 (1), this Assembly resolves that the Speaker do refer any report received in accordance with Article 183 (3) of the Constitution of Kenya, 2010 to the relevant County Assembly Committee. The floor is now open for debate. Yes, honourable Wilson Derebia.

**Hon. Derebia:** Thank you Mr. Speaker. I rise to support the Motion. Mr. Speaker, from your communication today you said that where need be people will have to meet and you set the Covid-19 rules and regulations. I remember in our committee we need to visit Mwema and we cannot do it virtually so we will just follow your guidance. As we go for the recess, we are nearing the end of the month. As we go home I don't know how you will answer us Mr. Speaker because our pockets are empty and we are approaching the 25<sup>th</sup> which we approved here that we will not be lacking funds. i.e. the 25<sup>th</sup> of every month. So we made an agreement with the Cooperative Bank.

Mr. Speaker I support the Motion.

**Hon. Deputy Speaker:** Thank you honourable Wilson Derebia. Yes, honourable Muchiri member for Karingani.

**Hon. Muchiri:** Thank you honourable Speaker. I rise to support. I like the mood and the spirit that was in the one who was writing our Standing orders when he said that if any message come from the Governor and the Senator... I am still waiting for any message from the Senator for the last three years we have been in this House, I believe it is good to share this Standing Order with the senator to know that he is part of this Assembly.

I support and say that we must continue with our business regardless of the situation. The Corona virus is here and I believe one day it will end but the people of Tharaka Nithi need the services that we are supposed to render to them especially when it comes to things that have to be done on the ground. Even the president himself has not closed down his offices. Even the National Parliament is still running. I think after the messages have been conveyed to the Speaker and transmitted to the various committees we need to work on them more

seriously than before. Let me quote the minority leader when he said that they need to visit Mwema tea buying centre so that they can investigate my statement. I know that when it comes to travelling we are travelling. We are moving but when it comes to working we start seeing the Corona virus. People are in the market. People are buying and selling but when it comes to church, the Corona virus comes. As a House we need to move on with or without the pandemic because I know that one day this thing will end.

Thank you honourable Speaker.

Hon. Deputy Speaker: Thank you. Yes, honourable Bonifacia Njeri Kigwari.

Hon. Njeri: Thank you Mr. Speaker. I rise to support the Motion. However, it is important that we all take individual responsibility and carry out our duties because we don't know when this pandemic is going to end so we cannot stop operations but instead we should take individual responsibility. This is especially when it comes to committee level. A good example is about two weeks ago we had to round inspecting the KRB roads and the ongoing roadworks and so there is no way our work can just come to a standstill because of Covid-19. People have to eat and work and we have no idea when the pandemic will end. So somehow, as we have been advised by the ministry of health let us take individual responsibilities and continue with business as usual but with maximum precaution. We should also sensitize the community as we do our work.

With that Mr. Speaker I support.

Hon. Deputy Speaker: Thank you honourable Bonifacia Njeri. Yes, honourable Anita.

Hon. Anita: Thank you Mr. Speaker. I rise to support. I don't want to repeat what others have said but I think that we always get communication from CAF from one member and we have two representatives. I have a schedule from CAF and I believe this schedule is not to be forwarded to the respective committee but to the members because I can see on the 13<sup>th</sup> of April we are supposed to start the deliberations for CAF on the summit because I believe that the country will not come to a standstill. Business will not come to a standstill. Most of us are business people and we have not closed our business and we are handling people. The only thing that we can do is take individual responsibility because getting Corona virus is not a collective responsibility. We need to be cautious but I believe Kenya need to move on. The Assembly business needs to move on.

With that and before we adjourn you can tell us when to start practicing for sports so that we can go to Mombasa for the Assemblies' Sports.
